- I. Call to order - Meeting called to order by Margaret McNamara at 1:34pm.

- II. Approval of Minutes –September 27, 2018. Minutes were reviewed. Motion to approve by Mary Sundberg, seconded by Marc Wildman.

- III. Library curriculum project- A secondary level Information Literacy Course is being written. The class is composed of online lessons that are student facing. Betsy Hartnett brought and shared the course outline for people to look at. Topics/Units include: Basic Digital Literacy, Hoaxes and Fake News, Internet Safety and Privacy, Finding Reliable Information, Social Media, and Research. Betsy Hartnett offered new unit titles to align with ISTE standards. These ISTE Standards are:
 - Basic Digital Literacy (Information Access)**
 - ISTE 2b Engage in positive, safe, legal, and ethical behavior when using technology, including social interactions online or when using networked devices.*
 - ISTE 3d. Build knowledge by actively exploring real-world issues and problems, developing ideas and theories, and pursuing answers and solutions.*
 - Internet Safety and Privacy (Information Security)**
 - ISTE 2a: Cultivate and manage their digital identities and reputations and are aware of the permanence of their actions in the digital world.*
 - ISTE 2d. Manage their personal data to maintain digital privacy and security and are aware of data-collection technology used to track their navigation online*
 - Social Media (Information Sharing)**
 - Hoaxes and Fake News (Information Evaluation)**
 - ISTE 3b. Evaluate the accuracy, perspective, credibility, and relevance of information, media, data, or other resources*
 - Pop Plagiarism (Information Use)**
 - ISTE 2c. Demonstrate an understanding of and respect for the rights and obligations of using and sharing intellectual property*
 - Research (Information Application)**
 - ISTE 3a. Plan and employ effective research strategies to locate information and other resources for their intellectual or creative pursuits.*
 - ISTE 3c. Curate information from digital resources using a variety of tools and methods to create collections of artifacts that demonstrate meaningful connections or conclusions.*

One of the advantages of the online curriculum is that NOVELny sources and other available articles can be embedded, and can authenticate directly to these resources. There will be a January pilot of two units by the OHM PTECH program. The long-term goal is to create an 80 lesson sequence of 40 minute lessons for a high school to easily incorporate into a curriculum.

Council members discussed ways that the course might be implemented in a school. There was agreement regarding the merits of such a course.
